Tuesday, February 8, 10am, via ZOOM* Benoit Bazinet: THE BEES OF BEECHWOOD

Born in Cornwall, Ontario and raised in the Eastern Ontario towns of St-Albert and Casselman, Benoit Bazinet started working at local funeral homes at the early age of 16. In 1996, he graduated with full honours from the Funeral Services Program at Cambrian College/Collège Boréal in Sudbury, Ontario. As a licensed Funeral Director, he has made Ottawa his hometown since 1996.





In the mid 80's Ben's godfather tended and hosted a communal family garden on his farm land. It was here at the age of 12 that Ben was introduced to beekeeping. In the mid 90's, while at High School in Casselman, he looked after his biology teacher's apiary and thereby gained "hands on" experience as an apiarist.

In 2016, Ben proposed an urban beekeeping green initiative to Beechwood's Management and Board of Directors. His proposal was unanimously approved.

Ben's presentation will touch on the evolution, anatomy, social structure and behaviour of the modern honeybee colony, the importance of pollinators to our food chain, and contributing factors to the decline of bees and native pollinators. He will conclude with what we can do to help.
